Methods for cleaning up

Small spills, absorb or cover with dry earth, sand, or other inert noncombustible absorbent material and place in waste containers for disposal. Large spills, dike area to prevent from spreading. If possible, pump liquid to disposal containers. Remaining liquid can be treated as a small spill and absorbed with suitable noncombustible material and placed into disposal containers.
